A meeting of the Gosper County Board of Commissioners was convened in open and public session at 9:00 a.m. on December 13, 2022, at the Gosper County Courthouse, Elwood, Nebraska. Present were Chairperson Terry Lerdall and Members Bruce Bader and Glenn Hofman. Clerk Cynthia Evans was present to record the proceedings. Also present was County Attorney Beverly B. Louthan.

Notice of the meeting was given in advance thereof by publication in the Valley Voice, Cambridge, NE on Dec. 1, 2022. Availability of the agenda was communicated in the published notice. All proceedings of the Board were taken while the convened meeting was open to the attendance of the public.

The undersigned Clerk hereby certifies that these minutes were written and available for public inspection within ten (10) working days after the date of said meeting.

The meeting was duly called to order and Chairman Lerdall announced and informed the public that a current copy of the Nebraska Open Meetings Act is posted on the wall of the meeting room.

Motion by Bader, seconded by Hofman to approve the minutes of Nov. 30, 2022. Roll Call Vote: "Aye" Lerdall, Bader, Hofman, motion carried.

David Hueftle was present and submitted a Survey and Resolution. Motion by Bader, seconded by Hofman to approve **Resolution No. 22-19** approving a subdivision of a tract of land in the NW1/4 of Section 20, Township 8 North, Range 23 West, to meet the requirements of the Gosper County Zoning Ordinance. Roll Call Vote: "Aye" Lerdall, Bader, Hofman, motion carried.

Shawn Boyd, Surveyor with Miller & Associates was present and submitted a proposal regarding appointment for the Gosper County Surveyor. Hwy. Supt. Mike Snyder was present. Discussion was held regarding Wayne Dietz, who is currently serving as the County's appointed surveyor. No action was taken.

Hwy. Supt. Snyder was present and gave a road report.

Motion by Bader, seconded by Lerdall to approve the Memorandum of Understanding for Community-Based Juvenile Services Aid for Fiscal Year 2022-2023 with no monetary contribution from Gosper County. Roll Call Vote: "Aye" Hofman, Lerdall, Bader, motion carried.

Motion by Hofman, seconded by Bader to approve the Clerk of the District Court report for the month of November. Roll Call Vote: "Aye" Lerdall, Bader, Hofman, motion carried.

Motion by Bader, seconded by Hofman to approve the Pledged Security Reports from Security First Bank dated 12/1/22. Roll Call Vote: "Aye" Lerdall, Bader, Hofman, motion carried.

The Board reviewed two applications for the Courthouse Building Supt. position. The Board will hold a Special meeting on December 19th at 3:00 pm at the Courthouse to conduct interviews.

The Board adjourned at 10:55 a.m.

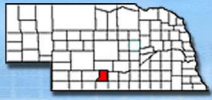
